5. Treasurer's Report: Highlights

- a. Purchase of replacement items continues; keeping a list of things to report what was lost that wasn't on the insurance list
- b. Received two large checks from CM totaling \$413,622.80. Paid Belfor all but \$61,930.30 which is considered 'outstanding reserve' by Insurance Co. There are still a few loose ends that Belfor needs to finish before the final money can be released.
- c. We received additional \$12,000 in donations in November for the Basement project. An additional \$5,000 in pledges is expected. We have paid Uhrig \$223,462.51 of \$254,848.35 (approx. 88%). No further checks will be issued to them until more progress is seen. At this point in time, we have more than needed to complete the project which means that some 'other sources' will not be needed. Any extra specified donations made will be applied to outstanding loan balance.
- d. We no longer need to use savings for basement project.
- e. We have paid 50% of the flooring costs as down payment. (\$7,972.50)
- f. Investments are showing some gains but still below our highest balances.

- g. Setting up a payment to get a light replaced in the parking/front of church
- h. Jingle project is now bringing in about \$50 per week; passing the plate also seems to be bringing in more donations.

Motion by Karen/Bill to approve Treasurer's Report. Motion approved.
