2. Minutes from Previous Meeting:

Motion by Dan/Noah to approve August minutes as written. Motion approved.

- 3. **Correspondence**: Copy of correspondence/complaint sent to the Bishop by Donn and Susan Jaynes regarding the lights and the carillon. Synod informed them that this is a local matter to be resolved with the Vicar and Council of Mt. Zion. Discussion followed. We have a permit for the lighting, which is installed for safety, and we have made several previous adjustments to the carillon system to try to help this complaint. Missy will inform Donn and Susan Jaynes that we can forward the information to our Mutual Ministry Committee, where concerns between members and leadership are addressed. If they accept this path, Dan Batz will lead the Mutual Ministry Committee in this effort.

5. Treasurer's Report:

- a. Reviewed the reports / highlights:
 - Received the check for the \$90,000 loan; April deposited it into our demand checking account to use for paying for the basement renovations. UPDATE from previous minutes: With the unsecured loan, we get it as a lump sum then pay that back.
 - Received part of the money from Church Mutual towards the organ
 - Donations have remained low, but we are still in the black

- We have about \$60,000 in the account to purchase things that we need to replace (cabinets, tables, supplies, etc.). There is also money in the Christian Ed fund that we can use for CE needs.

6. Committee Reports:

- a. Christian Education (all levels Fegely/Batz/Dietrich)/M. Fegely & K. Wanamaker
 - Sunday school: Christian Education Committee met on September 1st. Highlights from the report:
 - Discussed starting up fresh with supplies and storage
 - Michelle mentioned that she will be updating the list of Christian education volunteers
 - Confirmation: no separate report
 - Youth Group: First meeting will take place in October
- b. Evangelism- Not active
- c. Finance Committee April Osterstock / Greg Schappell Met August 30th
 - Council reviewed the budget for next year
 - April explained that it looks larger due to projects, but it is in fact the lowest actual budget in several years outside of the projects
 - 5% raises were designated for Sylvia and Martin; Vicar did not want a raise, but we will add a higher amount to his retirement instead
 - Extra funds were designated for fuel to help with higher costs
 - April noted that the figures she provided for this year will change as we finish out this fiscal year with income and expense
 - Greg/Michelle motioned to approve the 2022-2023 budget and send it to the Congregation for their approval on October 9th. Motion approved.

- g. Property Martin Billger / Noah Grube
 - Thanks was given to Noah for his work organizing the stonework project. He reported that most of the items discussed at the last Property Committee meeting have already been updated or covered.
 - Vicar's updates: Lights are up; carpet is in; mulch is spread; waiting on news for fixing pew tops—looks like it should be covered; water line has been moved; The basement floor is ground down for where the epoxy floor will be for the kitchen
 - Fridge and freezer have been ordered and will be donated by members; Cost of stoves will also be covered by donation. While these costs will be covered by insurance, the donations leave us more money to be used towards paying back the loan.

 - If parents are inactive, should everyone in the family become deactivated from the roll? Yes, unless the older children are completing the eligibility requirements on their own.
 - When are confirmed students considered adults? They become eligible adult members at Confirmation. They will receive envelopes in the future/moving forward. They get their own record at that point for attendance, communing, and giving. Confirmed students would become inactive if they don't meet requirements after Confirmation.
 - Should confirmation and Sunday school students get envelopes?
 Possibly. This would teach them about giving even if it is a small amount donated.
 - Voting membership is defined more specifically than active membership::
 - Mt. Zion Constitution C8.02: *Voting* members are confirmed members. Such confirmed members, during the current or preceding calendar year, shall have communed in this congregation and shall have made a contribution of record to this congregation. Members of this congregation who have satisfied these basic standards shall have the privilege of voice and vote at every regular and special meeting of the congregation.
